The area of operation spreads over four districts of Kerala viz Thiruvananthapuram, Kollam, Alappuzha and Pathanamthitta.

#### **Requirements**

- 1. Chartered Accountant firm should have minimum ten years of experience in the field of providing Audit service.
- Preference will be given to those Chartered Accountant/ Chartered Accountant Firms having its office at four southern districts of Kerala viz. Thiruvananthapuram, Kollam, Alappuzha and Pathanamthitta.
- 3. To make a Chartered Accountant firm eligible to submit Expression of Interest, the firm must have an annual turnover of at least Rs.30 lakhs during the financial years 2020-21, 2021-22 and 2022-23 on an aggregate. The audited Income and Expenditure statement or Income Tax returns for the respective years shall be submitted along with the Technical offer. In the absence of such an enclosure the offer will be summarily rejected.

#### Audit fees

The unit wise audit fee shall be quoted which is inclusive of all travelling expenses of the persons engaged for audit, all other related expenses and shall include GST.

#### The Scope of Audit

The Finacial Audit shall cover specific transactional activities of units for the period from 01-04-2019 to 31-03-2024

The work includes:

1.Verification of milk and milk products transactions from production/products department to Marketing Department and subsequent sales proceeds.ie verification of reconciliation of goods transfer between production /products Department and Marketing Department and reconciliation of sales proceeds between Marketing Department and Finance Department.

2.Verification of sundry debtors. Critically examine credit outstanding during the audit period.

3. Verify the adequacy and accuracy of accounting, financial controls including application of accounting standards and the General Financial rules and compliance with prudent accounting principles.

4. Verify all records of purchase of Milk & Milk Products, other Raw materials, Equipment & Machineries, Machinery/Equipment Spare parts, Consumables, Packing Materials, other Store items and repairs and maintenance etc..

5.Verify all records related to processing/manufacturing of milk and milk products, Despatch/sales, and all other operations performed.
