1. The agency shall be recognized by FSSAI for food safety auditing.
2. Rate quoted shall be for entire man days inclusive all taxes
3. The selected agency shall complete the audit within one month time.

### **Liquidated Damages:**

If the bidder fails to complete the audit within the time period specified in the contract, TRCMPU shall without prejudice to its other remedies under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to

- a. 0.5 % of the unexecuted contract value for each week of delay. The total amount so deducted shall not exceed 5% of the contract value, once the maximum is reached, we may consider the termination of the contract.
- b. However, genuine reasons if any will be given due consideration against documentary evidence before operating this clause.
- c. Any incidental taxes and levies on account of delay in performance of the contract by the bidder shall be at his account.
