### **TERMS & CONDITIONS**

Thiruvananthapuram Regional Cooperative Milk Producers' Union Ltd. (TRCMPU) invites competitive rates for the Supply of Veterinary Medicines as per annexure - 1 to its four district units situated at Thiruvananthapuram, Kollam, Alappuzha and Pathanamthitta.

#### **1. Eligibility and qualification requirements:**

- a) **The bidder should be in business as Manufacturer of Veterinary Medicines and the items supplied by the bidder must have the same banner / label under which they participated in the bid.**
- b) The firm participating in the tender should have a turnover of more than 5 Crores per annum.
- c) The companies/manufacturers participating in the tender should have a full-fledged R&D (Research and Development) facility in India or Abroad. The R&D certificates issued by central government to the medicine manufacturing companies must be produced along with the tender form. Tenders without R&D certificate will be rejected.
- d) The items specified in the tender should be manufactured through a unit having WHO-GMP, GMP certification and GLP certification and the bidder should produce the copy of the certificates which are liable for detailed and cross verification by the authorities for participating in the tender process.
- e) The manufacturer of a particular medicine should be a reputed company with a market stand of minimum 15 yrs and atleast 10 years in Kerala at the time of bid opening.
- f) All medicines supplied must be locally available in the general market through prescription at present.
- g) The bidder shall furnish documentary evidence for the above including copy of Income Tax Returns (certified true copies) for the previous two years, failure of which will lead to disqualification.
- h) Medicines of poor quality and that are introduced only for tender purpose will not be considered.
- i) All bids submitted shall also include the following information.
  - I. Copies of original documents defining the constitution or legal status, place of registration and principal place of business of the company or firm or partnership or if a joint venture, of each party there to constituting the bidder.
  - II. Copy of GST registration certificate.
  - III. Details of experience and past performance of the bidder on works of similar nature, and details of current works in hand and other contractual commitments shall be submitted.

#### **2. Tender Fee & Earnest Money Deposit**

- a) The Tender fee and EMD as given in the invitation to bid shall be accepted via online transaction only, through the site [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in).
- b) Tender Fee (Bid Submission Fee) shall be non-refundable.
- c) EMD of the unsuccessful tenderer shall be released immediately after the award of the contract to the successful tenderer.
- d) The EMD of the successful bidder shall be released after cent percent supply of items.
- e) No interest shall be paid for the EMD towards the period for which it lies in deposit.

#### **3. Quantity of items:**

- a) List of veterinary medicines required are specified in **Annexure - 1**.
- b) **Managing Director, TRCMPU Ltd., reserves the right to increase the quantity of items to be purchased, up to a maximum of 40 % of the quantity mentioned against each items in this tender document.**

4. **Agreement:** - The successful bidder has to execute an agreement on Rs. 200/- Kerala stamp paper within 15 days of receipt of order. Model format of the agreement is provided in **Annexure – 2**.

5. **Delivery & Billing Address:** -

6. **Terms of payment:** -

100% payment shall be released within 30 days of receipt of the items in satisfactory condition, as per the purchase order.

7. **Note to Bidders:**

- Bidders are advised to note the Tender ID and Tender No. & Date for reference.
- All uploaded documents should contain the signature and the office seal of the bidder/authorized persons and should be digitally signed while uploading. Documents uploaded without digital signature shall entitle rejection of the tender.
- The Managing Director, TRCMPU Ltd., reserves the right to reject any or all the technical bids, if he finds the same would safeguard the best interest of TRCMPU.
- The price bid of only those bidders who qualify in the technical bid will be opened.

- e) TRCMPU does not bind itself to accept the lowest offer and reserves the right to accept any offer in part or full without assigning any reason. The bidders shall not have any claim in this regard.
- f) Hard copies of the documents mentioned under cover 1 and copy of this tender document duly signed on all pages to be submitted within a day or two from the date of opening. Non-submission of hard copies by the bidder may lead to rejection of their offer.
- g) The final acceptance of the tender rests entirely with the Managing Director, TRCMPU, who do not bind themselves to accept the lowest or any tender.
- h) If the successful tenderer fails to execute the supply of items as per the purchase orders within the stipulated time, the earnest money deposited by them will be forfeited to TRCMPU and the contract arranged elsewhere. In case where a successful tenderer, after having made partial supply, fails to execute the contract in full, all or any of the material not supplied, may, at the discretion of the undersigned, be purchased by means of another tender / quotation or by negotiation or from the next higher tenderer who had offered to supply and the losses, if any, caused to TRCMPU shall thereby together with such sums as may be fixed by TRCMPU towards the damages be recovered from the defaulting tenderer. Even in cases where no alternative purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate given in the tender of the defaulter shall be forfeited and balance alone shall be refunded.
- i) The EMD, shall subject to the condition specified herein, be returned to the bidder after cent-percent supply of items, but in the event of any dispute arising between TRCMPU and the Bidder, TRCMPU shall be entitled to deduct out of the EMD the corresponding amount of such damages, and the expenses as may be claimed, until such dispute is determined.
- j) The Bidder shall not assign or hand over the contract or the benefits or burdens thereof to any other person or body corporate. The bidder shall not underlet or sublet to any person or persons or body corporates, the execution of the contract or any part thereof without the consent in writing from the undersigned, who shall have absolute power to refuse such consent or rescind such consent (if given) at any time, if he is not satisfied with the manner in which the contract is being executed and no allowance or compensation shall be made to the bidder or the sub-contractor upon such rescission. Provided always that if such consent be given at any time, the bidder shall not be relieved from any obligation, duty or responsibility under the contract.
- k) Every notice hereby required or authorized to be given may be either given to the bidder personally, or left at his residence or last known place of abode/business, may be handed over to his agent personally or may be addressed to the bidder by post at his usual or last known place of abode/business and if so addressed and posted shall be deemed to have been served on the bidder on the date on which, in the ordinary course of post, a letter so addressed and posted would reach his place of abode/business.
- l) The tenderer shall undertake to supply materials according to the standard sample and/or specifications.
- m) No representation for enhancement of rates once accepted will be considered.
- n) Samples should be forwarded, if called for, and the unapproved samples shall be collected back by the tenderer at their own cost. Sample sent by VP post/freight to pay will not be accepted. The approved samples may or may not be returned, at the discretion of the undersigned. Samples sent by post, railway or plane should be so dispatched so as to reach the undersigned not later than the date on which the tenders are due. TRCMPU will not be responsible if any sample is found to be missing at any time due to the non-observance of the provisions of this clause. Tenderers whose samples are received late will not be considered. Sample should be forwarded under separate cover duly listed and the

corresponding numbers of the item in the tender schedule should also be noted in the list of samples.

- o) **The price quoted should be inclusive of all duties, cesses etc., as per the format in the BOQ.** No additional claim other than above shall be entertained subsequently.
- p) **The rates shall be valid for a period of one year from date of opening of tender and TRCMPU reserves the right to increase the quantity of items to be purchased, upto a maximum of 40% of the quantity mentioned against each items in this tender document.**
- q) **The field provided in the BOQ for entering "All-inclusive Unit Rate" shall be filled judiciously. If the bidder is not quoting for a particular item, the corresponding field should be left blank.**
- r) Special conditions, if any, of the tenders attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the undersigned.
- s) Bills/invoices must be raised as per the billing addresses mentioned in the purchase order.
- t) The consignments have to be sent as freight paid. Materials sent on Freight to pay basis or negotiation of dispatch document through Bank will not be accepted.
- u) Supply shall be effected preferably within 30 days from the date of purchase order. However, the supply shall not be delayed beyond a maximum of 45 days from the date of purchase order. Delivery after the specified period is subjected to confirmation from this office.
- v) Payment will be made directly to the company to whom the purchase order is issued, unless the bidder endorses an authorised supplier to execute the order and collect the payment on their behalf. All incidental expenses incurred by TRCMPU, if any, for making payments shall be borne by the bidder.
- w) Any product newly introduced shall be actively marketed by the firm in Kerala state for at least 1 year to be considered for selection.
- x) All products must clearly indicate the date of manufacture and expiry. **Products shall have at least 3/4<sup>th</sup> of its shelf life remaining as per specified storage conditions from the date of supply. This condition is to be abided strictly. Any deviation from the said clause will be viewed seriously to the extent of rejection of goods supplied. The payment for the goods received will not be effected and such goods will be returned to the consignor at their own expense.**
- y) All claims shall be addressed to the undersigned.
- z) Arbitration - In case of any dispute, the Registrar of Cooperative Societies, Kerala, shall be the sole Arbitrator as per the provisions of Kerala Cooperative Societies Act - 1969.
- aa) Jurisdiction – Thiruvananthapuram (Kerala) only.

### **General Guidelines for e-Procurement**

This tender is an e-Tender and is being published online for the supply of items as mentioned in the Invitation to Bid. The tender is invited in two cover system from the registered and eligible parties through e-procurement portal of Government of Kerala (<http://www.etenders.kerala.gov.in>). Prospective bidders willing to participate in this tender shall necessarily register themselves with above-mentioned e-procurement portal. The tender timeline is available in the critical date section of this tender published in [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in).

#### **A) Online Bidders registration process:**

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on "[www.cca.gov.in](http://www.cca.gov.in)." Once, the DSC is obtained, bidders have to register on "[www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)" website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost. #### **B) Online Tender Process:**

The tender process shall consist of the following stages:

- i) **Downloading of tender document:** Tender document will be available for free download on "[www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)" from the date & time of publication of e-tender, till the last date & time for online submission of e-tender. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document. Downloading of tender documents will not be possible after the date specified above.
- ii) **Pre-bid Meeting:** NA
- iii) **Publishing of Corrigendum:** All corrigenda shall be published on "[www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)" and shall not be available elsewhere.
- iv) **Bid submission:** Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document to "[www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in)." No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- v) **Opening of Technical bid and bidder short-listing:** Technical bids will be opened, evaluated and shortlisted as per the eligibility and technical qualification. All documents in support of technical qualification shall be submitted (online) within the due date and time. Failure to submit the documents will attract disqualification. Bids shortlisted by this process will be taken up for opening the financial bid.
- vi) **Opening of financial bids:** Bids of the qualified bidders shall only be considered for opening and evaluation of the financial bid on the date and time mentioned in the critical date's section.

#### **C) Documents comprising bid:**

- i) **First Stage (Pre-qualification or Technical cover based on 1 cover or 2 cover tender system):**

Pre-qualification or technical proposal shall contain the scanned copies of the documents mentioned in the Terms & Conditions (Clause 1. Eligibility and qualification requirements) which every bidder has to upload.

The department doesn't take any responsibility for any technical snag or failure that has taken place during document upload.

- ii) **The Second Stage (Financial Cover or as per tender cover system):**

The Bidder shall complete the Price bid as per BOQ in spread sheet format given for download along with this tender.



**Note: - The blank price bid should be downloaded and saved on bidder's computer without changing file-name; otherwise price bid will not get uploaded. The bidder should fill in the details in the same file and upload the same back to the website.**

**Fixed price:** Prices quoted by the Bidder shall be fixed during the bidder's performance of the contract and not subject to variation on any account. A bid submitted with an adjustable/variable price quotation will be treated as non-responsive and rejected.

**D) Tender Document Fees and Earnest Money Deposit (EMD)**

The Bidder shall pay a tender document fee and Earnest Money Deposit or Bid Security as given in the Tender Inviting Notice. The Bid security is required to protect the purchaser against the risk of Bidder's conduct, which would warrant the forfeiture of security.

During the online bid submission process, the bidder shall select **SBI MOPS** option and submit the page, to view the **Terms and Conditions** page. On further submitting the same, the e-Procurement system will re-direct the bidder to MOPS Gateway, where two options namely **SBI** and **Other Banks\*** will be shown.
