## **milma** General Terms & Conditions for e-Procurement

This e-Tender is being published for services as mentioned in the Invitation to Bid. The tender is invited in two-cover system from the registered and eligible parties through e-procurement portal of Government of Kerala (<u>http://www.etenders.kerala.gov.in</u>). Prospective bidders willing to participate in this tender shall necessarily register themselves with the above mentioned e-procurement portal. The tender timeline is available in the critical date section of this tender published in <u>www.etenders.kerala.gov.in</u>.

#### A) Online Bidders registration process:

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on <u>www.cca.gov.in</u>. Once, the DSC is obtained, bidders have to register on <u>www.etenders.kerala.gov.in</u> website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

#### B) Online Tender Process:

The tender process shall consist of the following stages:

- i) **Downloading of tender document**: Tender document will be available for free download on <u>www.etenders.kerala.gov.in</u> from the date & time of publication of e-tender, till the last date & time for online submission of e-tender. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document. Downloading of tender documents will not be possible after the date specified above.
- ii) **Pre-bid Meeting:** NA
- iii) **Publishing of Corrigendum**: All corrigenda shall be published on <u>www.etenders.kerala.gov.in</u> and shall not be available elsewhere.
- iv) Bid submission: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document to www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- v) **Opening of Technical bid and bidder short-listing:** Technical bids will be opened, evaluated and shortlisted as per the eligibility and technical qualification. All documents in support of technical qualification shall be submitted (online) within the

due date and time. Failure to submit the documents will attract disqualification. Bids shortlisted by this process will be taken up for opening the financial bid.

vi) **Opening of financial bids:** Bids of the qualified bidders shall only be considered for opening and evaluation of the financial bid on the date and time mentioned in the critical dates section.

#### C) Documents comprising bid:

i) First Stage (Pre-qualification or Technical cover based on 1 cover or 2 cover tender system):

Pre-qualification or technical proposal shall contain the scanned copies of the documents mentioned in the Terms & Conditions (Clause 1. Eligibility and qualification requirements) which every bidder has to upload.

The department doesn't take any responsibility for any technical snag or failure that has taken place during document upload.

#### ii) The Second Stage (Financial Cover or as per tender cover system):

The Bidder shall complete the Price bid as per format given for download along with this tender.

## Note: - The blank price bid should be downloaded and saved on bidder's computer without changing file-name otherwise price bid will not get uploaded. The bidder should fill in the details in the same file and upload the same back to the website.

**Fixed price**: Prices quoted by the Bidder shall be fixed during the bidder's performance of the contract and not subject to variation on any account. A bid submitted with an adjustable / variable price quotation will be treated as non-responsive and rejected.

During the online bid submission process, bidder shall select *SBI MOPS* option and submit the page, to view the *Terms and Conditions* page. On further submitting the same, the e-Procurement system will re-direct the bidder to MOPS Gateway, where two options namely *SBI* and *Other Banks*\* will be shown. No other mode of submission shall be accepted and such tenders will be rejected outright.

#### **TERMS & CONDITIONS**

E-tenders are invited from reputed Manufacturers/authorized suppliers for supplying approximately 1000 numbers ( $\pm$  10%) of Microwave ovens to TRCMPU Ltd, Head Office located at *Ksheera Bhavan, Pattom, Thiruvananthapuram-04*.

#### 1) Eligibility & Qualification Requirements

The bidder shall have

- i. Experience in marketing of home appliances/electronic goods.
- ii. Valid GST registration certificate.
- iii. Manufacturer authorization certificate
- 2) All uploaded documents should contain the signature and the office seal of the bidder/authorized persons and should be digitally signed while uploading. Documents uploaded without digitally signing shall entitle rejection of the tender.
- **3)** The Bidder shall pay a tender document fee of Bid security and Earnest Money Deposit as mentioned in tender notice. The Bid security is required to protect the purchaser against risk of Bidder's conduct, which would warrant the forfeiture of security.
- **4)** The bidder shall mention the unit rate and GST amount clearly in the Bill of Quantities (BOQ) file. The rates shall be inclusive of all incidental expenses like freight charges, insurance, etc. Once the rates are finalized and purchase order placed, no additional payment shall be endorsed.
- 5) The Successful Bidder should execute an agreement in non-judicial stamp paper (Kerala) worth Rs. 200/-, assuring satisfactory completion of work as per the Purchase Order. The bidder should also remit Rs.100000/- as Security Deposit to this office, *via* demand draft drawn in the name of the Managing Director, TRCMPU Ltd., payable at Thiruvananthapuram or as Bank Guarantee equivalent to the above amount and valid for a period of 3 months which shall be released upon successful completion of work in accordance with the terms and conditions of the tender document and purchase order.

#### 9) Terms of payment

90% of the order value will be released within 10 days from the date of supply of goods in satisfactory condition as per the terms and conditions stipulated in this tender document and purchase order and upon submission of proper invoices. Remaining 10 % will be released after 90 days from the date of purchase order or after successful completion of distribution whichever is earlier.

Unless otherwise stated the payment shall be made to you by Crossed Account Payeeat-par cheque /NEFT/ RTGS according to the terms of payment mentioned in the purchase Order as well as the account details and payment instructions mentioned in the invoice.

#### 10) Shipping and Billing Particulars

The items as per the purchase order shall be billed and supplied to the addresses mentioned in the delivery schedule on FOR basis, within 15 days of receipt of the order.

#### 11) Cancellation of Contract

TRCMPU shall be free to cancel the order either in part or full, in the case of noncompletion of work or breach of any of the clauses mentioned herein or in the purchase order.

#### 12) Force Majeure

The terms and conditions mutually agreed upon shall be subject to Force Majeure Clause. Neither the bidder nor TRCMPU shall be considered in default in performance of his/their obligations here under if such performance is prevented or delayed because of war, hostilities, revolution, civil commotion, strike, epidemic accident, fire, wind, flood, earthquake or because of any law and order proclamation, regulation or ordinance of any Government or any other cause whether of similar or dissimilar nature, beyond the reasonable control of the party affected. Should one or both the parties be prevented from fulfilling his/their contractual obligations by a state of Force Majeure lasting continuously for a period of six months, the two parties should consult each other regarding the future implementation of the contract/work order.

#### 13) Arbitration

In case of any dispute, the Registrar of Cooperative Societies of Kerala State shall be the sole Arbitrator as per the provisions of Kerala Co-operative Societies Act 1969.
