3. Terms of payment : Payment shall be made from TRCMPU as follows:-

- 100% of the order value shall be released upon satisfactory supply of the items with GST invoices.

4. Evaluation & Selection Process:-

The selection of the supplier shall be carried out based on the Quality and Cost Based Selection (QCBS) method to ensure a transparent and effective evaluation process. The evaluation shall be based on a total score of 100 with Technical Evaluation carrying 50% weightage and

Financial Evaluation carrying 50% weightage. The supplier securing the highest combined score shall be ranked H-1 and considered for award of contract. Financial scores shall be assigned on an inverse proportion basis, with the lowest priced proposal receiving the highest financial score, and other bids scored proportionately. Technical scores shall be normalized based on the highest technical score. In case of a tie in final score, the bidder with the higher technical score shall be ranked higher.

5. Weightage

Under the QCBS methodology, the Technical Evaluation shall carry 50% weightage and the Financial Evaluation shall carry 50% weightage for the final selection of the bidder. The minimum qualifying technical score shall be **35 marks out of 50**.

The bidder shall ensure visually appealing, durable designs using high-quality materials, printing and finishing standards. The entire supply and delivery to designated locations shall be completed on or before 30.05.2026.

Deliverables:

- Design, manufacture and supply of 1700 School Bags (20 Ltr & 40 Ltr), 1700 Rain Coats, 1700 Pencil Pouch with Pen, Pencil, Scale, Eraser & Sharpener and 932 Adult Raincoat with Trouser set (XXXL) as per approved specifications and artwork.
- Submission of design concepts and final artwork for approval before production.
- Proper branding, printing, packing and delivery of materials to all designated TRCMPU

- Ltd. locations.
- Completion of entire supply on or before 30.05.2026.

GENERAL TERMS & CONDITIONS

1. Inspection

All items supplied under this tender shall be subject to inspection by TRCMPU Ltd. at any stage of manufacture or prior to dispatch. The supplier shall ensure internal quality checks before offering materials for inspection. TRCMPU reserves the right to inspect materials at any stage and may reject items not conforming to specifications. The supplier shall not dispatch materials without written clearance/approval from TRCMPU Ltd. All relevant quality certificates, test reports (if applicable), and sample approvals shall be submitted as required.

2. Dispatch Instructions

All materials shall be properly packed and dispatched to the respective delivery locations mentioned in the tender. The supplier shall ensure safe transportation to avoid damage during transit. Dispatch shall be made strictly as per instructions issued in the Purchase Order. All consignments shall be dispatched on freight-paid basis unless otherwise specified. Delivery challan, invoice and packing list shall accompany each consignment.

3. Insurance

The supplier shall be responsible for ensuring safe delivery of goods. Transit insurance shall be arranged by the supplier unless otherwise specified in the Purchase Order. In case of any damage or loss during transit, the supplier shall be responsible for replacement or rectification of the goods at no additional cost to TRCMPU Ltd.

4. Delivery

Time of delivery is the essence of the contract. The supplier shall strictly adhere to the delivery schedule specified in the Purchase Order. The entire supply shall be completed on or before **30.05.2026**. No delayed delivery shall be accepted, and no payment shall be made for supplies delivered after the stipulated date.

5. Demurrage

Any demurrage or additional charges arising due to delay in dispatch or improper documentation by the supplier shall be borne by the supplier.

6. Rejection of Goods

TRCMPU Ltd. reserves the right to reject any or all items that do not

conform to the approved specifications or quality standards. Rejected materials shall be replaced by the supplier within the stipulated time at their own cost. Until replacement, rejected goods shall remain at the supplier's risk.

7. Submission of Bills

Bills shall be submitted in triplicate along with delivery challans, GST invoices and proof of delivery to the concerned units. Payments shall be released after successful inspection and acceptance of materials by TRCMPU Ltd., subject to applicable statutory deductions from the concerned units.

8. Cancellation of Contract

TRCMPU Ltd. reserves the right to cancel the contract wholly or partly in case of non-performance, delay in delivery, or breach of any tender conditions. In such cases, TRCMPU shall be entitled to recover any additional cost incurred due to procurement from alternate sources.

9. Subcontracting

Subcontracting of any part of the supply shall not be permitted without prior written approval of TRCMPU Ltd. However, the primary responsibility for quality, delivery, and compliance shall remain entirely with the main supplier.

10. Force Majeure

Neither party shall be held responsible for failure or delay in performance due to events beyond reasonable control such as natural calamities, strikes, epidemic, government restrictions, or other force majeure conditions. In such cases, both parties shall mutually discuss continuation or modification of the contract

11. Arbitration:

In case of any dispute, the Registrar of Co-operative Societies of Kerala State shall be the sole arbitrator as per the provisions of Kerala Co-operative Societies Act 1969.

12. **Jurisdiction:** Thiruvananthapuram Kerala only.
