#### ANNEXURE - I

#### **Terms and Conditions**

## Scope of Work:

Scope of Work Includes:

#### Assessment and Load Revision

- Evaluate the existing connected electrical load at the facility.
- Compare the assessed load with the sanctioned load under the current agreement with Kerala State Electricity Board (KSEB).
- Propose a revised connected load based on operational requirements and future expansion, if any.
- Initiate and complete the process for enhancement of sanctioned load with KSEB, including submission of necessary applications and supporting documents.

# Preparation of Technical Drawings and Schedules

- Prepare an updated Single Line Diagram (SLD) of the electrical system in accordance with KSEB and Electrical Inspectorate standards.
- Develop a revised Load Schedule reflecting the proposed changes in connected load and distribution.

## Submission for Statutory Approval

 Submit the revised electrical scheme, including the updated SLD and Load Schedule, to the Electrical Inspectorate for review and approval.

#### **Execution through Licensed Contractor**

- Engage a KSEB-licensed Electrical Contractor to carry out all mandatory documentation, application submissions, and coordination with statutory bodies.
- Ensure that all works are executed in compliance with the Kerala Electricity Supply Code and relevant safety regulations.

#### Inspection and Certification

- Facilitate inspection by the Electrical Inspectorate upon completion of the revision works.
- Obtain the statutory approval and completion certificate from the Electrical Inspectorate.

#### Eligibility Criteria:

Must possess a valid KSEB electrical contractor license (Class A/B).

- Experience in similar electrical projects (proof required).
- · Valid GST registration and PAN.
- · Should not be blacklisted by any Government agency.

#### **Statutory Compliance:**

All work must comply with:

- Kerala Electricity Supply Code
- CEA Regulations
- · Safety and inspection norms of the Electrical Inspectorate
- KSEB guidelines

# Time for Completion:

The entire work shall be completed within 45 days from the date of work order.

#### Payment Terms:

Payment shall be released by TRCMPU, Head Office as follows:

- 50% of the quoted amount for each part of the work (KSEB and Electrical Inspectorate) shall be payable upon submission of all relevant documents to the respective authorities.
- The balance 50% shall be payable upon receipt of the necessary approvals and completion certificate from the respective authorities.

- All statutory fees for inspection/approval shall be borne by the contractor and may be reimbursed by TRCMPU on submission of original receipts.

 The contractor must ensure minimum disruption to existing electrical services during execution.

- Work will be carried out as per the Terms and conditions and Technical Specifications issued by TRCMPU Ltd.
- The bidder shall have to pay liquidated damages @ 0.5% (Half percentage) of order value per day, for the delay in completion of the work.

- The work has to be carried out without affecting the day-to-day operation of the office.
