**1. Supply of Shrink wrap film for 1000 ml PET bottle**

**2. Specification :** Spec of the shrink wrap film is given below.

- Material : LDPE
- Size : Width- 560 mm
- Thickness : 90+/-2 micron
- Weight of the roll : Approx 30 kg
- Bottle size : 1000 ml
- Matrix : 4x3
- Line speed : 40 bottles/min

**3. Price :** Price quoted should be for F.O.R, and inclusive of GST.

**4. Payment :**100% Payment will be made on receipt of the articles in good condition and according to the specifications within 10 days of receipt of duly signed tax invoice. The item will be accepted by the respective consignees only if the articles received are in good condition and according to the specifications or otherwise the lot will be rejected.
